NOW THIS DEED WITNESSETH:-

- 1. The Name of the Trust shall be KURIAKOSE ELIAS EDUCATIONAL TRUST and in short shall be referred as "KEET".
- 2. The registered office of the Trust shall for the time being at CMI PROVINCIAL HOUSE, VAZHUTHACAUD, TRIVALDRUM. The Settlors are at liberty to shift the registered office to any other place in India, when circumstances warrants.
- referred decision of the Provincial Council, the Settlors, had made over to the Trustees the sum of &.5,000/- (Rupees Five thousand only) to hold the same together with all additions and accretions thereto and all other properties that may be acquired out of the same or otherwise and may herein after be the subject matter of the Trust (hereinafter referred to as the TRUST FUND) for objects and purposes herein after expressed with powers and on the terms and conditions herein contained, converning the same.
 - 4. Objects of the Trust:-
- a) To co-ordinate the activities of the existing educational institutions under the St.Joseph's CMI Province Trivandrum of the CMI Congregation with the sole moto of serving the public at large under the principles of the CMI Congregation.

- b) To start new educational institutions or to take over any existing institutions, in the best interest of the students of the existing institutions, any where in India, and to manage it and develop it with the sole moto of rendering educational facilities to the public, expecially to the community of Christian Miority, if circumstances permit.
- c) To institutions awards, loan, scholarships or free scholarships, prize, medals etc. for the encouragement of pupils and teachers in the field of education, art, culture, science religion, and the like utilising the funds, found in surplus for the time being or from funds gathered for tuch specific purposes.
- (d) To incur any other expenditure charitable nature not specifically provided above, if circumstances warrants.
- (e) To engage in all legitimate activities which are incidental or condusive for the attainment of the objects referred above in sub clauses a,b and c to this clause.
 - 5. Board of Trustees:-
- (a) For the time being, the second part, to this Deed Fr. Thomas Kalayil CMI shall be the sole trustee.
- (b) Within one month of the registration of this

 Deed of Trust, a Board of Trustees shall be formed by him,
 inviting the following members.

(i) Fr.Lucas Vithuvattival CMI, being the Provincial, as the President of the Board of Trustees.

(ii) Himself being the Secretary, for Education of the HIST CENTRAL SCHOOL (iii) Province as the Vice President of the Board of Trust.

(111) Fr. Thomas Vempala CMI as the Secretary of the Board of Trustees.

 - (c) The President and Vice-President shall always be the provincial and the Secretary of Education of the Province of the St.Joseph CMI Province Trivandrum, Ex-Officio.
 - The Provincial Council of the St.Joseph's CMI Province Trivandrum is at liberty to remove any of the members of the Board, except the ex-Officio members and to nominate new members, as and when found necessary by them.
 - The members of the Board shall not be entitled for any remuneration, but any expenditure incurred by them in connection with attending the meeting or other affairs of the Trust may be re-imburssed to them.
 - (f) The Board shall be empowered to appoint from among themselves or from outside, Chief Officers by name. 'Principal', 'Director', 'Local Manager', 'Administrator' etc. to take charge of one or more particular institution or institutions, under the Trust, and to fix their remuneration from time to time, and to terminate their service, whenever the Board feels necessary to do so.

The Board members if appointed in this capacity are eligible to get the remuneration fixed by the Board.

- 6. Meetings of the Board:-
 - (a) The Board of Trustees shall meet as often as required and shall meet atleast twice in a calendar year and approve the annual accounts and forward it to the Settlors of the Trust after duly audited by a Chartered Accountant.
 - (b) The meeting of the Board of Trustee shall be presided over by the President of the Board of Trustees and in his absence by the Vice-President and in the absence of both, by any one of the Trustees nominated by the President.
 - (c) There shall be three days notice to the meeting of the Board of Trustees unless it is waived by all the members eligible to get the notice.
 - (d) Decisions may also be taken by circulation, provided all the members agree to it.
 - (e) The quorum for the meeting shall be five.
 - (f) The Secretary shall serve the notice for the meeting in consultation with the President and he shall be responsible for the maintenance of the minutes Books and other records of the meeting.

7. Powers and Duties of the Board of Trustees:-



- b. To invest the funds of the Trust in any manner they deem fit constistent with the objects of the Trust and in the interest of the Trust, provided such investment in immovable properties shall be subject to the approval of the provincial Council of the settlors of the Trust.
- c. To borrow any amount or to continue to avail of the amount already borrowed, either on pledging the assets of the Trust or otherwise, from individuals, banks, financial institutions or other institutions, with or without interest, for any objects of the Trust.
- d. To acquire, alter extend, demolish of its assets, movable or immovable and to dispose of the same whenever found necessary in the best interest of the objects of the Trust.
- e. Start new units of the present activities at other places or to take up new activities whenever necessary or to take over and manage any institution or activity now carried on by others, as long as it is found to be advantageous to achieve the objects of the Trust.
- f. Subject to the approval of the Settlors, to join,

 Co-operate, or amalgamate this Trust, with other Trust,

 or found or institutions as the Trustees think fit.

8. Powers and Duties of the CHIEF OFFICER:

- a) To Work, manage, control and supervise the affairs/ management of the properties now or hereinafter belonging to the institution of the Trust and develop them.
- b) To enter into any contract or agreement for and on behalf of the Trust of the institution of the Trust, which are beneficial to the interest of the Trust.
- c) To appear and act for and on behalf of the Trust in all legal proceedings before any competent authority.
- d) To appoint and constitute Advocate or other attorneys, whenever necessary and to remove them whenever be feels such removal is necessary.
- e) To take loans or borrow money, as decided by the Board of Trustees and to execute promissory notes, bonds or the like for the same and to discharge the same by repayments.
- f) To gather funds towards corpus or otherwise, for the

 Trust by way of donations or otherwise, from any person

 or institution, either in cash or in kind for the purpose



- i) The chief Officer shall sue and be sued for and on behalf of the Trust, provided that the Board of Trustees shall have the power to authorise any one of its members to represent the Board of Trustees in any legal or other proceedings, under special circumstances.
- j) The Chief Officer shall exercise and perform such powers and duties as the Board of Trustees may from time to time determine or assign or otherwise him to do.
- k) To do any and all acts and deeds and things necessary for the efficient management and administration of the Trust and other properties of the Trust.
- 1) The Chief Officer shall have the power to delegate his duties and functions to any other members of the Board of Trustees or member of the staff of the Trust, with the consent of the Board of Trustees.
- m) All acts, deed and things lawfully done by the Birector by virtue of these present shall be binding on the Trust.

9. Powers of the Provincial Council of the Settlors of the Trust:-



10. Bank Accounts:

b) In the case of individual institutions, the Chlef Officer along with a nominee of the Board of Trustees shall open and operate bank accounts jointly.

11. Miscellaneous:-

- a) All question at any meeting of the Board of Trustees shall be decided unanimously or by the majority of members present and voting at the meeting and in the case of equality of votes, the person presiding over the meeting shall have a casting vote.
- b) Any provision in this Deed may be amended, annulled or substituted by the Provincial Council of the Settlors of the Trust at any time provided that the Prior approval of the Commissioner of Income Tax shall be obtained before making any amendment in respect of the Object clause in the Deed, in case the Trust has been given any benefits or exemption in respect of Income Tax Liability.
- c) In the event of the Trust becoming impossible to function in accordance with the provisions of the Trust Deed, the assets of the Trust after discharging of all its debts and liabilities shall be handed over to such other institutions with similar or allied objects, with the approval of the Settlers.

12. Saving Clause :-

(a) The benefit of the Trust shall not be denied to any on account of caste, creed and community.

b) It is expressly declared that no part of the Trust

property or its income shall be applied for any purposeNAGER
